We bring this to the ME/CFS community's attention because disgraceful and threatening behaviour like this should be brought to the light of day.

The MEA is currently acting illegally in relation to the MEA Elections and in the refusal of this charity to provide its current Register of Members. What other illegal actions is the MEA perpetrating we wonder?
